<u>Safety & Security – Rick Grimsley:</u>

Rick is on vacation this month. There have been reports of pool gate and a door left open. (Thank you, clubhouse monitor, for catching these things.

This past month, there have been two times that a homeless person has spent the night on our property on Nutmeg. We are doing our best to not make it comfortable for homeless people to do that.

The glass door between the clubhouse main room and pool deck has been repaired; it now slides very easily.

Clubhouse Reservations - Betty Biggs:

There are no reservations at this time.

Unfinished Business:

- The work on the Nutmeg sprinklers and the trimming of the bushes has been completed.
- The work on the brow ditch is still pending. We will be getting another bid.

New Business:

- Beverly made a motion to accept the contract from North County Tree in the amount of \$9600
 for the first half of the work. Motion was seconded and approved by voice. The first half will
 involve the removal of several trees and some trimming. The second half, to be done next year,
 will be the grinding of stumps and the remainder of the trimming.
- Debra made a motion to accept the contract from El Plantio Nursery in the amount of \$2277.00 per month. Motion was seconded and approved by voice. Two men (and a third if needed) will be here for 5-6 hours every Thursday to do the work.
- The Board has received and is reviewing the list from the Evacuation/Sheltering Committee which gives needs and methods of necessary evacuation.

Open Forum – There was none.

Debra expressed her thanks to the many people who have stepped up and volunteered in repairing items on our property to make our neighborhood "top notch."
